This Pomeranian is being sold for the price of \$\_\_\_\_\_. All payments are non-refundable. In addition, all shipping expenses are the responsibility of the buyer. Deposits are non-transferable. Once initial payment is received, the Pomeranian is owned by the buyer and all veterinary care will be the buyer's expense.

It is understood that this Pomeranian must be shown and awarded an AKC championship title. This Pomeranian will not be mated before achieving AKC championship title. The buyer will make every effort to title this Pomeranian. This Pomeranian will remain in co-ownership between the buyer and the breeder until the AKC championship title is awarded. All show expenses will be paid by the buyer. The buyer will provide a show photo and championship certificate to the breeder. The breeder will sign off of all registration documents pertaining to this dog when all terms of the contract have been met. Should anything unforeseen happen to the breeder (such as death), then full ownership will transfer solely to the buyer.

This Pomeranian is being sold as a show prospect (defined as having no disqualifying faults for his or her age on the date of this sale). A definitive evaluation is made on puppies at 8 weeks and 18 months of age(per Pat Hastings Structure Evaluation) and cannot be made between those ages. Males will have two testicles descended into the scrotum at maturity or a replacement will be made when one becomes available (replacement is the only option). I must receive a statement (including puppy identification) from your vet by 6 months of age stating that all remaining puppy teeth were extracted or the guarantee of an even to scissor bite is null and void.

The new owner has 48 hours from the date of shipping/transfer to have the Pomeranian examined by a veterinarian of their own choice, at their own expense. If the vet exam reveals that the Pomeranian is diseased, the buyer must return the Pomeranian along with a written statement from the attending vet as to the health problem, for a replacement Pomeranian when one becomes available. Replacement is the only option. Any difference in price will be the buyer's responsibility. Returning the Pomeranian will be at the buyer's expense. There is no guarantee against accidents. No veterinary bills will be paid by the breeder.

It is agreed that at no time will the owner sell or give this Pomeranian or any of his offspring to a pet store, a kennel, a puppy mill operation, a dog pound, or a dog broker or any similar enterprise. In the event that the owner needs to find a new home for this Pomeranian, the breeder will be offered first right of refusal. The breeder expects that you will make good decisions with full consideration of the welfare of the breed when finding homes for any offspring produced by this Pomeranian.

This Pomeranian is sold with no warranties, either expressed or implied in an "as is" condition with no guarantees other than those stated herein. This agreement represents the entire agreement between the parties. This agreement shall be governed by the state of Michigan and all claims, disputes or other matters between the parties of this agreement shall be brought in Delta County Court, Escanaba, Michigan. When breeder and buyer execute this agreement, it will be binding upon both parties, subject and pursuant to the terms and conditions herein.
